Update to fees and costs information

Following a periodic review of the estimated fee and cost information in the Trusts' PDS, the following updates are made to the PDS effective from 30 June 2023:

1. The fees and costs table on page 20 of the PDS is deleted and replaced with the table below:

- 2 These costs are paid from the assets of the Trust as and when they are incurred. This is the estimated percentage by which each Trust's investment return has been reduced by transaction costs.
- 3 Some underlying investment managers may charge performance fees from time to time. Estimated performance fees and total management costs (which include estimated performance fees) are subject to change without prior notice. The estimated performance fees listed are indicative and have been based on the annualised performance fees as an average of the past five financial years incurred for each Trust as at 30 June 2022.
- 4 The actual buy-sell spread may differ from the estimated spreads listed. Buy-sell spreads are subject to change from time to time without prior notice.
- 2. In the sections entitled 'How are performance fees charged?' on page 21 of the PDS and 'Transaction costs' on page 22 of the PDS, each time the date '30 June 2021' appears it is deleted and replaced with '30 June 2022'.
- 3. The table on page 23 of the PDS providing an example of annual fees and costs for a balanced investment option is deleted and replaced with the table below:

Equals cost of IOOF MultiMix Balanced Growth Fund		If you had an investment of \$50,000 at the beginning of the year and you put in an additional \$5,000 during that year, you would be charged: \$685* What it costs you will depend on the fees you negotiate.		

* Additional fees may apply: Establishment fee \$0. And, if you leave the managed investment scheme early, you may also be charged exit fees of 0% of your total account balance (\$0 for every \$50,000 you withdraw). This example assumes the \$5,000 contribution occurred at the end of the first year, therefore it does not include the management fees and costs on the additional \$5,000 invested, nor any market movement on the total amount invested. You may also be charged a buy-sell spread whenever you make an investment, withdrawal or investment switch. The estimated sell spread applied to withdrawals from the Trust is currently 0.10% (this will equal \$5 for every \$5,000 you withdraw).
